New Items

The match between the Misfits and Main St Bar & Grille was played under protest. The Board of directors reviewed the match sheet and gathered information from Amy Lacasse (Captain of Main St. Bar & Grille) and Warren Bedard of the Misfits. The Match Report Sheet was not completely filled out by Main St before the start of play. Main St. did not fill out the singles matches. Both 601 Games were played before this was caught and brought up. The board was told that the Misfits captain had written the names on the scoreboard and begun match play. This was confirmed by Warren. After the 601 games were played and recorded, a picture of the incomplete Match Report Sheet was sent to Lucien LeVeille. Once the mistake was caught by Amy Lacasse, she began filling in the lineup for the singles matches. Lucien was asked to give a ruling on how to proceed. Since Dan Croteau was at the same venue as Lucien, Lucien asked Dan. Dan said to allow her to fill it out and play the games. This led to the protest.

The board of directors looked over the Match Report Sheet and found that some of the singles matches were not played. Warren admitted that his match against Rene Poulin was not played because they both agreed to not play since the matches “wouldn’t count”.

It was brought up that the match between Amy Lacasse and Ryan Prestin was not played. It was said that the names were written up on the board and Ryan waited 10 minutes for Amy and she had not shown up. Ryan had to work the next day so he left.

Matches played under protest still need to be played to completion.

After reviewing the sheet and hearing from players on both sides, Zuri Chambers made the motion to not count the singles matches because we were unable to really make any headway on what was written in. Lucien LeVeille seconded the motion. The match was now won by the Misfits by a score of 6 to 3. Dan Croteau decided to allow all notables to remain as we had no way of telling if those were earned during the singles matches or not.

- It was brought to our attention that the throw lines at Main St Bar & Grille were off. Someone at the match measured and replaced the lines using a chain.
- Amy Lacasse was reminded that the Away team fills out the Match Report Sheet first to completion and then the Home team fills out the Match Report Sheet to completion.
- Due to numerous issues at Main St. Bar & Grille, it has been decided that we will not have any teams out of there beginning next season (Spring 2023).
- Warren Bedard told everyone that we are okay to have a Luck of the Draw tournament out of the Legion on December 26th 2022 since we do not have darts that week.
- Players need to be courteous and not interrupt other ongoing matches.

- Restructuring the League.
