## **New Items**

- Dan Tremblay will not be playing for Round of 9
- Items brought up by Dan Croteau
  - In the 2 point Call Cricket, the shot must be called loud enough for the scorekeeper to hear. No one else needs to be able to hear the call, only the thrower and scorekeeper.
  - o To vote on later Regarding coaching in 301, Wording says Captains can coach in 301 games. Rewrite to specifically state Captain and Co-Captain.
  - To vote on later Regarding Bylaws section on coaching 301 games, reword to state all singles games.
  - O Bars have been advised to shut down matches @ 11:30pm. Unfinished matches will have to be finished at a later date.
  - Match report sheets need to be filled out by 7:45 and darts are to fly no later than
     8:00pm
  - o If a captain is assisting a player, the player does NOT need to disengage from the line to receive assistance.
  - o If a team's captain is keeping score, they are NOT allowed to coach. They can only say xx hit, xx remains. Captains may not tell a player what to throw at or what double is left while keeping score.
- Reminder, we have teams and players who have not paid their dues. Dues must be collected before a player or team may throw another dart or those games that the unpaid player threw in will be forfeit.
- Items brought up by Lucien LeVeille
  - Regarding filling out Match Report Sheets
    - Home team fills out top section including date, match number, Division, and the names of the competing teams.

- Home team then folds the Match Report Sheet in half and gives to Away team's captain or Co-captain to fill out their player's names.
- Player's Full names must be used once on Every Week's sheet
- When Away team is done listing their players, the Match Report Sheet is given back to the Home team's Captain or Co-Captain so they can fill out their line-up.
- Once the Home team has filled out their side, the Match Report Sheet can be unfolded and the match begins.
- All lines must either have the name of a registered player or a single line through that spot.
- When using a Sub in the event that a player may not be there, the sub is written in parenthesis. Ie, Player (Sub). The person who did not play in that game should have a single line drawn through their name ie. Player (Sub).
- o American Board Representatives
  - Another player approached me asking about having two members of the American Division act as representatives to the Board of Directors to handle disputes between captains without having to contact one of the Board of Directors
    - Concept was discussed and turned down.
- o Set Break times during matches
  - A player asked if we could put in the bylaws set break times such as after the 501 games, give 5-10 minutes before the start of cricket.
    - Idea was discussed and turned down. It is the player's responsibility to make sure they have enough time between games to head out for a break so as to not disrupt the flow of the match.
- Add in provision to allow 5 minutes after names are written on scoreboard before forfeit.
  - A player had heard some people say to write names on the scoreboard, call the players to the line and if one team has not shown up within 5 minutes of the names being called, call a forfeit. The player asked about adding this to the bylaws.
    - Discussion was held, idea was well received. No motion was made to add to bylaws but captains seemed receptive to adding this as a rule.
       Will revisit again later
- o Board lighting at Main Street Bar & Grille very dim and difficult to see board.
  - Several players have spoken to me about the board lighting at Main Street
     Bar & Grille.
    - Due to certain circumstances, we will have to deal with the lighting for the remainder of this season. We will revisit for next season.
- Players who are not involved in matches handling and filling out the Match Report
   Sheet
  - A Co-Captain approached me about an incident in Week 1's matches where a
    player from a team that was not involved in the match not only filled out the
    scores for the match without being asked but also did so incorrectly.

• A discussion was held and it was determined that unless a person is a part of the match (or a designated record keeper as allowed within the bylaws) they should not be touching the Match Report Sheet to alter it in any way.
