- Amy Lacasse's meeting fine from the November meeting was paid per Zuri
 - Paul McKenzie will not be in attendance for the meeting. His fine was already turned In to Zuri
 - Dan Croteau – President – called the meeting to order at 7:02 PM
 - Playoffs start December 22nd 2025
 - First and second place will have a bye week
 - Third place plays 6th place @ 3rd's home court
 - Fourth place plays 5th place @ 4th's home court
 - Semi-Finals will be on December 29th 2025
 - 1st place plays the lowest remaining seed @ 1st's Home court
 - 2nd place plays the higher remaining seed @ 2nd's home court.
 - The playoff finals will be played on January 5th 2026
 - The Spring 2026 season will start on January 12th 2026

 - Just to reiterate, there is no outside food or beverages allowed in the venues. This is a state law and can cause the venues we play in to receive a heavy fine and possibly lose their liquor license. Anyone caught bringing in food or drink from outside will receive a one season suspension minimum.

 - On November 10th there was a situation where a player suffered a medical emergency. The bartender went to help out with the situation and players from another match were getting upset that they were unable to get a drink. Upon finding out there was a medical emergency, some inappropriate comments were made. This has already been addressed but we wanted to reiterate that many players in the North Country Dart League do have underlying health issues and while we hope things like this never happen to anyone, we need to comport ourselves in a kind and professional manner if situations arise. Be respectful of the person and situation, even if it means staying out of the way or getting the door for EMS if needed
 - Zuri – Treasurer – Informed us that the meeting fines for Northland Interiors, Just the Tip, and Bedard and son have not been turned in.
 - Kenny Nett – Vice President – said Mike Smith knows someone that is interested in playing next season. Dan said that he has spoken with Mike Smith about this and because Charlene,

Bookworms captain, will have to replace 2 players next season, he will be passing this person's information over to her.

- Steph Chilafoe of the bookworms asked a question about the match report sheet. She asked, if the paper is filled out, should the tablets be entered the same way? Apparently in the match between Sharp Shooters and the Bookworms, names were entered in a different order than what was written on the sheet. Steph stated that she held up play and requested for this to be fixed.
 - Dan said that Steph handled the situation correctly. They went to find help to get the issue corrected. Dan said that playing under a different name will affect that person's stats so this was handled properly.
 - Lucien – Secretary - also clarified that if players do play under a wrong name, it can be fixed on the back end of things as long as they continue to play under the wrong names. Captains can reach out to Lucien and explain the situation and who played under what name.
 - Zuri also reiterated that it's best to go back and edit the names if the match has not started yet. This does make things a lot easier.
- Steph Chilafoe also said that the previous night the match between Sharp Shooters and the Bookworms finished around 12:30am Tuesday morning. She asked what the "cutoff time" was for matches.
 - Dan Croteau said that after 11:30 PM the bartenders can shut a match down but it was up to the bartender's discretion after 11:30PM.
